**6.1** Directors must be elected or appointed to the following Board positions, and a director, other than the president, may hold more than one position. Directors shall serve a term of two (2) years:

(a)president;(b)vice-president;(c)secretary;(d)treasurer.

Role of Vice-President:

#### **Proposed Amendment:**

**6.4** The Vice-President is the vice-chair of the Board and is responsible for carrying out the duties of the President if the President is unable to act. The Vice-President shall succeed the President upon completion of his/her term.

- Questions and comments:
  - -Kayla Vandermolen is there a title for the President once their term is complete for example "Past President"? Discussion: Identified that the new Board of Directors is responsible for bringing this to a board meeting for determination.
  - -Jonathon O'Riordan: the appointment is for two years in the role.
  - -Kayla Vandermolen Does this mean a Board Director can sit on the Board after their 2-year term in a position is complete? Discussion: The Bylaws do not currently restrict this.
